It has been proposed that churches provide a link to the iVoterGuide.com web site for congregants interested in obtaining information about candidates for state and federal office in their localities. A congregant using the link would reach the iVoterGuide.com homepage, which contains no campaign intervention, but does allow the reader to click a button to obtain access to voter guide information that could not be provided by a section 501(c)(3) organization. Several clicks would be required before such information is reached, and the information could be reached only by a deliberate decision by the reader to proceed to that information.

Under these circumstances, I do not believe a church or other section 501(c)(3) organization making the link available would be engaged in campaign intervention.
